- 3. Attested copies of certificate in proof of educational qualifications, experience, age, date of birth along with original documents and publications should be produced at the time of interview.
- 4. If needed written test will be conducted for the discipline concerned, before the commencement of the interview.
- 5. No TA/DA will be paid to the candidates for attending the interview.
- 6. The candidate if selected will discharge all such duties that are attached to the post as per KAU Act/Statues/Regulation & Rules and that may be assigned to him/her from time to time by the Head of the organization.
