- 4. Attested copies of certificates in proof of educational qualification, experience, age, date of birth along with original documents and publications should be produced at the time of interview
- 5. If there are more number of applicants a written test will be conducted for the discipline concerned before the commencement of the interview
- 6. No TA/DA will be paid to the candidates for attending the interview
- 7. The candidate, if selected will discharge all such duties that are attached to the post as per KAU Act/statues/regulation & rules and that may be assigned to him/her from time to time by the Head of the organization
- 8. The ACCER/KAU has the right to terminate the service of the temporary appointment if the performance is found unsatisfactory.
