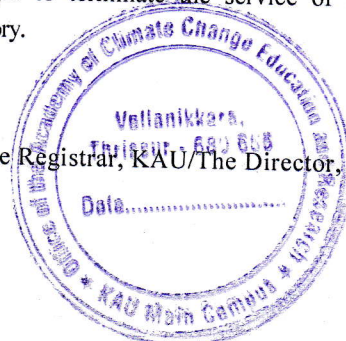

5. If there are more number of applicants a written test will be conducted for the discipline concerned before the commencement of the interview
6. No TA/DA will be paid for attending the interview
7. The candidate, if selected will discharge all such duties that are attached to the post as per KAU Act/statues/regulation & rules and that may be assigned to him/her from time to time by the Head of the organization
