Qualification

Essential:

a) Bachelor's degree from the concerned Faculty recognized by the Kerala Agricultural University (**For Faculty of Agriculture/Others** - In the case of Co-operation and Banking basic degree in subjects in Co-operation and Banking shall be mandatory) /

Bachelor's Degree in Agricultural Engineering recognized by the Kerala Agricultural University (For Faculty of Agricultural Engineering).

b) Masters degree in the relevant subject recognized by the Kerala Agricultural University with a minimum of 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree recognized by the Kerala Agricultural University from an accredited foreign university. The relaxation in minimum mark is applicable as per Sec 3.4 (I), 3.5 and 3.6 of UGC Regulation 2018 to the eligible candidates.

c) NET conducted by ICAR/UGC/CSIR/AICTE or similar test accredited by the UGC or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET:

Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/ Institutions subject to the fulfilment of the following conditions:-

a) The Ph.D. degree of the candidate has been awarded in a regular mode;

b) The Ph.D. thesis has been evaluated by at least two external examiners;

c) An open Ph.D. viva voce of the candidate has been conducted;

d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;

e) The candidate has presented at least two papers based on his/her Ph.D work in conferences/ seminars sponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency.

The fulfilment of these conditions is to be certified by the Registrar or the Director/Dean (Academic Affairs) of the University concerned.

Note: NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

OR

The Ph.D degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

Desirable:

1) Knowledge in Malayalam language to read and write.

2) Ph.D. in the relevant subject recognized by the Kerala Agricultural University.

Nationality & Age Limit

The candidate must be a citizen of India and shall not be over 40 years age as on 01.01.2020. The age limit is relaxable in the case of SC/ST/OBC and differently abled categories as prescribed in the KS&SSR 1958 as amended from time to time.

Reservation

Reservation benefit will be allowed as per the norms of Kerala Public Service Commission on production of Community Certificate (in case of SC/ST), 'Non-Creamy Layer certificate' (in the case of OBC) and Disability certificate (in the case of differently abled) issued by the competent authority.

Salary & Allowances

The scale of pay and allowances of Assistant Professor will be as per the Government orders issued in line with UGC norms.

Application Form & Fee

The mode of selection, applicable reservation, relaxation of age and all other matters relating to the appointment to the post mentioned above shall be governed by the provisions contained in the KAU statute, UGC regulations 2018 and orders issued by the Government from time to time.

Period of Appointment: The appointment to the post of Assistant Professor shall be for a period till the incumbents attain superannuation as laid down in Section 42(4) and (5) of Kerala Agricultural University Act.

- (i) The application should be in the format provided in KAU Website and should be down loaded in A4 size paper. All columns in the form should be filled in properly and legibly. If any column is irrelevant, the same should be filled up by the entry "N.A." that is "Not Applicable" and should not be left blank or filled up by dots or hyphen or any other mark.
- (ii) If there is a difference in the name of the candidate given in the application and that given in the documents, an identity certificate from a Gazetted Officer showing that the name given in the application and in the documents are of the same person, should be attached with the application.
- (iii) The envelope containing the application should be super scribed with the notification number, name of post and discipline applied for.
- (iv) Candidates who are employed on regular basis in Government/Quasi Government/State Autonomous Institution should send their applications through proper channel with No Objection Certificate.
- (v) Before applying for the post, the candidate should ensure that he/she fulfills the eligibility and other norms prescribed thereto.
