The committee has submitted the report on the above said case and recommended to give KAU fellowships to all the PG and Ph.D students admitted to Kerala Agricultural University through KAU entrance examination irrespective of the place of domicile and to restrict the number of students from outside Kerala to 10% of the total PG seats of KAU, in addition to ICAR allotment.

The report of the committee was placed before the 132<sup>nd</sup> meeting of the Academic Council held on 28.09.2018 and the Council has approved the recommendations.

In consonance with the decision of the 132<sup>nd</sup> Meeting of the Academic Council held on 28.09.2018 the following order is issued.

Sanction is hereby accorded to award KAU fellowships to all the PG and Ph.D students admitted to Kerala Agricultural University through the KAU entrance examination irrespective of the place of domicile and to restrict the number of students from outside Kerala to 10% of the total PG seats of KAU, in addition to ICAR allotment. If sufficient students are not available from Kerala, students from outside Kerala will be admitted above 10%.
