Sealed super scribed tenders are invited for providing manpower support for the following works at the Centre.

A1. Routine Hardware & Software management activities at the KAU Headquarters premises and the CITI, excluding supply of any kind of spares required for repairs. Approx. number of Desktops & Laptops is around 250. Exact details of the systems like make and model, configuration, age, present status etc. can be obtained by contacting the Systems Manager, CeG, KAU Headquarters. Items under warranty and items presently in non-working condition (junked) will not be covered by this contract.

A2. Management of the network backbone infrastructure including OFC terminations, LAN, WAN, Switches, Routers, Firewall, Wi-Fi etc. and connectivity inside the Main Campus including routine servicing of network peripherals, excluding supply of any kind of spares required for repairs

A3. Management of the KAU Central servers and servers inside the CeG & CITI.

A4. Routine maintenance and updation of the KAU Internet website.

A5. Maintenance of the telephone instruments inside the HQR premises, excluding supply of components and spares. Approx. no. of units is 150.

A6. Maintenance of telephone lines at user locations inside the HQR building premises.

Activities at A1 above will involve troubleshooting and maintenance of the Hardware systems both Laptops and Desktops along with OS, Software and Antivirus ecosystems under Windows XP, 7, 8, 10 & Linux (Ubuntu, Mint) at the specified locations. Since Hardware Maintenance is a critical requirement, support requests will have to be attended to within 2 Hours or less.

Activity at A2 will involve the monitoring & troubleshooting the WAN, LAN & Wi-Fi connectivity inside the CITI, HQR NOC and the Campus Area optical fiber network backbone, which extends over a span of approx. 6 km end to end. Resources supplied should have sufficient expertise in networking and

hardware maintenance, duly evidenced by documents. They should have currently valid networking certifications like CCNA etc. They should arrange their own transportation support to cover the span of the network. Since WAN monitoring is a continuous activity and WAN connectivity is a critical requirement, connectivity-related support requests will have to be attended within 15 minutes or less.

Activity at A3 above will involve installation and management of Windows servers (Windows 2003, 2008, 2012), Linux servers (Red hat, Cent OS), Kaspersky corporate antivirus Server systems and other software normally used by KAU. Windows & Linux networking knowledge is essential. Knowledge of server installation, migration, database backup and restoration is desirable. The details of the various packages and the mode of their deployment can be obtained from this office on specific request.

Activity at A4 above will require knowledge of web content creation and publishing.

A NIL Bill of work showing the actual service/support charge and along with the cost of the replaced/serviced components adjusted against the AMC charges should be submitted for each support call mentioning the Inventory ID/Seat of the Serviced Item to the Systems Manager, CeG, KAU on a daily basis. A monthly report of work mentioning each support call must also be submitted to Officer i/c of Networks, CeG, KAU

Support will include making available at least one qualified support personnel at our premises during normal office hours on working days (9AM to 5PM). The contract will be covered by an SLA, the details of which can be obtained from this office on specific request.

The tender form may be downloaded from the "Tender Related Documents" section in the KAU website (www.kau.in/tenders).The cost of the tender form will be accepted by way of DD in favour of Systems Manager, Centre for e-Governance, KAU Main Campus, payable at SBI, Vellanikkara and should be enclosed along with tender. Firms who are exempted from the payment of EMD should furnish copy of the currently valid certificates issued from Stores Purchase Department, Government of Kerala.

Tenders should be accompanied by an agreement as per format available in the KAU website (www.kau.in/tenders) under the "Tender Related Documents" section on Kerala stamp paper of value mentioned in the format. Tenderers should have IT/PAN registration and photo copy of the same should be attached with the offer. Income Tax as applicable will be deducted from the payments. Annual rates may be quoted.
