- 1. Tender should be submitted in the prescribed forms which can be downloaded from the website <u>www.kau.in/tenders.</u> The cost of the tender forms will not be refunded under any circumstances.
- 2. The sealed cover containing the tender should be superscribed "Tender for the supply of steal furniture" (along with the notification number) and addressed to the Associate Director, Regional Agricultural Research Station, Kumarakom, Kottayam dist., kerala PIN 686566
- 3. Each tender should be accompained by tender fee and an Earnest Money Dedposit (EMD) (a) 1% of the total rupee equivalent cost of the quoted items (subject to minimum of Rs. 500/-) by way of **two crossed Demand Drafts separately** for tender fee and EMD drawn in favour of **The Associate Director, Regional Agricultural Research Station, Kumarakom, Kottayam dist., Kerala, PIN 686566** payable at the State Bank of India, Kumarakom (Branch Code 70116). Late and incomplete tenders and tenders without EMD, tender fee and agreement will not be accepted. Firms who are exempted from payment of EMD should furnish copy of the currently valid certificate from the store Purchase Department, Govt. of kerala.
- 4. The tender should be accompained by an agreement in Kerala Stamp Paper worth Rs.100/-(Rupees one hundred only) and format can be downloaded from the above website.
- 5. The successful tender should execute an agreement in Kerala Stamp Paper worth Rs.100/-(Rupees one hundred only) and furnish a security deposit of 5% of the cost of the furniture quoted in the form of term deposit/ bank guarantee/demand draft drawn in favour of Associate Director, Regional Agricultural Research Station, Kumarakom, Kottayam dist., Kerala PIN 686566, payable at the State Bank of India, Kumarakom (Branch Code 70116), when directed from this office. - 6. The cost of the item, tax and other charges should be separately stated.
- 7. The exact specifications, details of make, model, name of manufacturer, warranty details etc., of the item must be clearly specified. Separate bids (Technical and Financial) should be enclosed along with the tender.
- 8. Prices quoted should be valid upto one year.
- 9. If any Bandh /strike/ any unexpected holidays occurs on the date of opening of tender, the tender will be opened at the same time on the next working day. The decision of the undersigned in finalizing the tenders shall be final and binding.

- 10. Withdrawal of tenders after its acceptance or failure to supply the equipment or not according to the specification will entail cancellation of the tender. The supply order will be issued on the acceptance of the tender and the invoice should be addressed to Associate Director, Regional Agricultural Research Station, Kumarakom, Kottayam dist., kerala, PIN 686566. The payment will be effected only after satisfactory supply of the items.
- 11. The successful tenderer should supply the items to RARS, Kumarakom within 15 days from the date of the receipt of the supply order. The Associate Director, Regional Agricultural Research Station, Kumarakom, reserves the right to remove the defaulted name from the list of suppliers permanently or for a specific period.
