Terms and condition:-

- 1 Tender should be submitted in the prescribed form which can be downloaded from the web link www.rarsptb.kau.in/tenders. The cost of tender form is Rs. 1000/- + 12% GST (ie. Total amount of Rs. 1120 /-) which will be accepted by way of Demand Draft drawn in favour of Associate Director of Research, Regional Agricultural Research Station, Pattambi payable at State Bank of India, Pattambi and should be send separately along with the tender.
- 2 The tender should be accompanied by an agreement in Kerala stamp paper worth Rs. 200/- (Rupees Two Hundred only), the format of which can be downloaded from the above website. Withdrawal of tenders after its acceptance or failure to supply the items or not according to the specification will entail cancellation of tender and forfeiture of S.D.

- 3 EMD amount of Rs. 5000/- should be remitted along with the tender cost of Rs. 1120/- by two separate Demand Drafts drawn in favour of Associate Director of Research, Regional Agricultural Research Station, Pattambi payable at State Bank of India, Pattambi. No other Demand Draft will be entertained.
- 4 The sealed cover containing the tender should be superscribed as "Tender for chemicals, glasswares, plasticwares and other labwares" as per tender notice No. D3- 4247/2021 dtd 26 .11.2021
- 5 Tenders can be **submitted up to 2 pm on 14 .12.2021.** Tenders received after the stipulated time will not be accepted.
- 6 Tenders will be **opened at 2.30 pm** on the same day in the presence of those bidders who are present at that time.
- 7 The bidder of the accepted tender should enter into an agreement with the Associate Director of Research, Regional Agricultural Research Station, Pattambi on Kerala stamp paper worth Rs 200/-. The format of the agreement is available in the web link www.rarsptb.kau.in/tenders. The EMD of the accepted bidders will be adjusted to Security Deposit which will be refunded after the period of contract.
- 8 The items supplied should be of specified quality as per the catalogue of the firm.
- 9 The items should be supplied in lots as required.
- 10 Payment of cost of the items will be made by invoice cum NEFT basis.
- 11 Any failure on the part of supplier in the fulfillment of contractual obligations will result in the forfeiture of EMD/Security Deposit.
- 12 Tenders insisting payment in advance either full or in part for releasing the documents through bank are liable to be rejected.
- 13 The undersigned reserves the authority to accept or reject any or all of the offers for items without assigning any reason whatsoever.
- 14 The decision of the undersigned in finalizing the tenders shall be final and binding.
- 15 Institutions under KAU are exempted (registered with DSIR) from payment of customs and excise duty for our procurements and hence prices quoted should be exclusive of these
- 16 All other technical and commercial terms and conditions as per the code rules in force in Kerala State will be applicable in this case also.

Special Conditions.

- 1 Highest possible discount rates offered against the catalogue price for each brand of chemicals/ lab wares should be quoted.
- 2 Special offers if any for each brand should also be mentioned.
- 3 For oligonucleotides primer synthesis rate per base pair should be quoted.
- 4 The items should be supplied within two weeks from the date of supply order. Further details can be had from the office during working hours.
