In suppression of the earlier notification of even No. dated 14/10/2022, applications in the prescribed format are invited from eligible candidates for temporary appointment of one Assistant Professor on contract basis (consolidated pay of Rs.44,100/-per month) in the discipline of Physical Education at College of Forestry, Kerala Agricultural University, Vellanikkara, Thrissur- 680656.

Essential Qualification:

- a) Masters degree in Physical Education recognized by the Kerala Agricultural University with a minimum of 55% marks in the traditional system or its equivalent grade in a point scale where grading system is followed. Only the qualifying marks without including any grace mark is permissible. The relaxation in minimum mark is applicable as per Sec 3.4(I), 3.5 and 3.6 of UGC regulation 2018 to the eligible candidates.
- b) NET conducted by ICAR/UGC/CSIR/AICTE or similar test accredited by the UGC.

Desirable:1) Knowledge in Malayalam language to read and write.

2) Ph.D. in the relevant subject recognized by the Kerala Agricultural University. **Nationality & Age Limit:** The candidate must be a citizen of India and shall not be over 40 years age as on 01.01.2022. The age limit is relaxable in the case of SC/ST/OBC and differently abled as prescribed in the KS&SSR 1958 as amended from time to time.

All other conditions are as per University norms.

The applications may be submitted in the attached format to the Dean of Faculty, College of Forestry, Kerala Agricultural University, Vellanikkara through email deanforestry@kau.in on or before 28.12.2022.
