3. Age of the applicant should not be above 40 years as on 31.05.2023. Age relaxation as per existing Government Rules will be granted to eligible candidates
4. Attested copies of certificates in proof of educational qualification, experience, age, date of birth along with original documents and publications should be produced at the time of interview
5. If there are more number of applicants a written test will be conducted for the discipline concerned before the commencement of the interview
