Candidates with prescribed qualification are invited to appear for a <u>Walk-in-Interview</u> scheduled on **24.11.2023** for contractual appointment of **Subject Matter Specialist** (Agronomy) and **Subject Matter Specialist** (Agricultural Engineering) on consolidated pay of Rs.44,100/- per month.

Educational Qualification:

- a. A Master's Degree with 55% marks (or an equivalent grade in OGPA/point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University or an equivalent degree from an accredited foreign University.
- b. NET conducted by ICAR/UGC or equivalent test approved by UGC or who are or have been awarded a Ph.D. degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be, exempted from NET.

Desirable: Knowledge in Malayalam language to read and write.

Nationality & age limit: The candidate must be a citizen of India and shall not be over 40 years of age as on 01.01.2023. Relaxation of upper age limit will be given to the eligible candidates as per existing rules.

All other conditions are as per Kerala Agricultural University Statute and relevant UGC Regulation.

Candidates should bring all relevant documents and report at KVK Palakkad at 10 am on 24.11.2023.

Terms and conditions

- 1. The appointment will be purely on provisional for a period of one year or till the appointment of regular hands whichever is earlier.
- 2. The candidates will have no claim in the University other than the consolidated pay specified for the post. Selected candidates will have to execute a bond in the prescribed format in the stamp paper worth Rs.200/- while joining duty. They will have no other claims for future appointment in the University or any other service benefits.
- Attested copies of certificates in proof of educational qualifications, experience, age, date of birth along with original documents and publications should be produced at the time of interview.
- 4. No TA/DA will be paid to the candidates for attending the interview.
- 5. The candidate if selected will discharge all such duties that are attached to the post as per KAU Act/Statutes/Regulations & Rules and that may be assigned to him/her from time to time.
- 6. The undersigned has the right to terminate the service of the persons temporarily appointed if their performance or any other action is subsequently found unsatisfactory without any notice.
