Age limit: The candidates shall not be over 36 years on the 1st day of January 2020. SC/ST and OBC are eligible for age relaxation as per KS&SSR.

The posting will be initially for a period of one year or till the completion of the project, whichever is earlier.

Interested candidates with required qualification are requested to appear for the personal interview to be conducted on **10/02/2020** at College of Forestry, KAU main campus Vellanikkara at 9.30 am

The candidate should produce their latest CV and the originals of the documents with a copy of each to prove age, qualification, experience etc. at the time of interview.

Terms and Conditions:

* Period of appointment: The appointment is purely on temporary and contract basis. There is no provision for re-employment after the termination of appointment.

* Age: Maximum age should not be above 36 years as on 01.01.2020. Age relaxation as per existing Government rules will be granted to eligible candidates.

* Remuneration: Consolidated pay of Rs. 21,000/- (Technical Assistant) and Rs. 34,000/- (Research Assistant) per month.

* If needed a written test will also be conducted for the discipline concerned, before the commencement of the interview.

* No TA/DA will be paid for attending the walk-in-Interview.

* An agreement in the prescribed form will be executed by the candidate in Stamp Paper worth Rs. 200/-, if selected for appointment.

* The candidates will have no claim in the University other than to receive the pay attached to the post.

* The appointment will not confer on him/her any right of permanency or regularisation in KAU.

* The candidate, if selected will discharge all such duties that are attached to the post and that may be assigned to him/her from time to time by PI/Co PI

* The University has the right to terminate the service of temporary appointment if the performance is found unsatisfactory or any such defects noticed.
