ORDER

As per the reference read as 1st above, University Grants Commission has directed to appoint Ombudsperson in every institution recognized by the University Grants Commission. Accordingly, as per the reference read as 2nd above, Dr. P. Ahamed, Professor (Retd.) & former Director of Students' Welfare has been appointed as Ombudsperson for Redressal of Grievances of Students in Kerala Agricultural University.

As per clause 6 (v) of University of Grants Commission (Redressal of Grievances of Students) Regulation' 2023, the Ombudsperson shall be appointed for a period of three years or until he/she attains the age of 70 years, whichever is earlier, from the date of assuming office, and shall be eligible for re appointment for another one term.

The tenure of Dr. P. Ahamed, Ombudsperson has expired on 29.12.2024.

In these circumstances, the following orders are issued.

- Dr. P. Ahamed, Professor(Rtd.) & former Director of Students' Welfare, KAU has ceased to serve as the Ombudsperson for Redressal of Grievances of Students, Kerala Agricultural University with immediate effect.
- 2. In accordance with provisions in Clause 6 of University of Grants Commission (Redressal of Grievances of Students) Regulation' 2023,

Dr. Jayasree Krishnankutty, Professor (Retd.) and Former Director of Extension, KAU is hereby appointed as the Ombudsperson of Kerala Agricultural University.

- 3. Dr. Jayasree Krishnankutty should assuming the charge of Ombudsperson to the undersigned.
- 4. The Ombudsperson shall perform the duties and responsibilities as prescribed in the University Grants Commission (Redressal of Grievances of Students) Regulations' 2023.
