3. The tender should be accompanied by an Agreement in Kerala stamp paper worth Rs.200/-(Rupees Two hundred only) in the format that can be downloaded from the website www.kau.edu/tenders OR rarspil.kau.in/tenders.
4. The sealed cover containing the tender documents should be super scribed as "Tender for Ride on rice Transplanter" **The cover should contain the DDs for tender cost, GST, EMD and the Agreement as mentioned above.**
5. The successful tenders should execute an agreement in Kerala Stamp paper worth Rs.200/-(Rupees Two hundred only) and furnish a security deposit of 5% of cost of the

8. The decision of the under signed in tender procedures will be final and binding

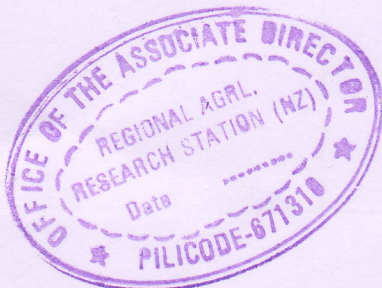


