Terms and Conditions

1. Tender form should be submitted in the prescribed form which can be downloaded from the web link www.rarsptb.kau.in/tenders. The cost of tender form will be accepted by way of Demand Draft drawn in favour of Associate Director of Research, Regional Agricultural Research Station, Pattambi payable at State Bank of India, Pattambi and should be enclosed along with the tender. The tender cost and GST amount should be specified while submitting the tender.

2. Cost of tender form is 0.2% of the quoted amount rounded to the nearest multiple of 100 subject to a minimum of ₹400/- (Rupees. Four hundred only) and a maximum of ₹1500/- (Rupees. One thousand five hundred only). There will be a GST of 12%.
3. The tender should be accompanied by an agreement in Kerala stamp paper worth ₹200/- (Rupees. Two hundred only) the format of which can be downloaded from the above website. Withdrawal of tenders after its acceptance or failure to supply the equipment or mismatch of specification will entail cancellation of the tender.
4. An amount equivalent to 1% of the amount quoted (subject to a minimum of ₹1500/-) should be remitted as EMD as a separate Demand Draft drawn in favour of Associate Director of Research, Pattambi payable at State Bank of India, Pattambi. Demand Draft from other banks will not be entertained.
5. The bidders claiming exemption from payment of EMD should produce documents in support of their claim.
6. The sealed cover containing the tender should be superscribed as “Tender for the supply of Tractor as per tender notice No. A3/2455/2023 dated 03.05.2023”
7. Tenders will be accepted up to 11.00 AM on 18.05.2023. Tenders received after the stipulated time will not be accepted.
8. Tenders will be opened at 11.30 AM on the same day at the presence of those bidders who are available at that time.
9. The bidder of the accepted tender should enter into an agreement with the Associate Director of Research, Regional Agricultural Research Station, Pattambi on Kerala stamp paper worth ₹200/-. The format of the agreement is available in the web link www.rarsptb.kau.in/tenders. He should also submit a security deposit equal to 5% of the cost of Equipment/Machinery in the form of Term Deposit/Bank Guarantee/Demand Draft drawn in favour of Associate Director of Research, Pattambi payable at State Bank of India, Pattambi.
10. The accessories supplied should be of the Tractor quoted for.
11. The supplier will be liable to provide spare parts for the tractor for a minimum period of 15 years from the date of supply.
12. There should be a minimum of five years warranty for both the Tractor and its accessories.
13. The equipment should be supplied within 15 days of receiving the supply order and the bidder should install and successfully demonstrate the operation of the supplied item.
14. The nearest authorised service centre and the minimum response time should be mentioned in the tender.
15. Payment of cost of the equipment/machinery will be made by invoice cum cheque/NEFT basis.
16. The bidder should hand over valid guarantee card wherein in conditions of guarantee are detailed and operation manual to the undersigned along with machinery/equipment.
17. Any failure on the part of supplier in the fulfillment of contractual obligations will result in the forfeiture of EMD/Security Deposit.
18. All other technical and commercial terms and conditions as per the code rules in force in Kerala will be applicable in this case also.

Special Conditions

1. Tenders insisting payment in advance, either in full or in part for the supply of the item are liable to be rejected.
2. Leaflets/brochures containing technical features of the models quoted for should be attached with the tender.
3. Operation manual and guarantee card of the item wherever required should be provided.

4. The decision of the undersigned in finalizing the tenders shall be final and binding.
