Sealed tenders are invited for Supply, erection and commissioning of steamer of lemongrass oil distillation unit in the farm.

Description of work

The station has 10 acres of lemongrass cultivation and for extraction of essential oil from the harvested leaves a steam distillation unit is installed in the farm. The unit comprises 2 Nos of 500 kg capacity SS chambers, steamer and condenser. The steamer made of MS has now rusted and damaged and it is proposed to replace the same with a newly fabricated steamer.

Technical parameters of the steamer

Stem capacity : 300 kg/hrFuel : firewood

Steamer plate : MS plate (8 mm)Super heated steamer : MS plate (8mm)

• Fire tube : ERW Boiler quality tube

• Fire box : 4 mm MS plate with 50 mm fire refractory

Fire bar : Cast iron
Safety valves : 2 Nos.
Steam pressure : 5 kg/cm2

Chimney

The existing chimney (8' length) should be placed outside the shed. It should be fixed on MS angle(1.5"x6mm) structured tower of 16' ht. on 2'x2' concrete foundation. The chimney should be connected to the steamer by providing a flue ducting using Aluminium pipe (5 m length, 10" width).

The puncturing made on the roof shed to connect the flue duct to the chimney should be properly sealed to avoid rain water leakage.

The existing 3 m long steamer outlet (connecting steamer to distillation chamber) should be replaced with 2" dia SS tube.

The steamer should be installed in the existing position of distillation unit erected in the farm. All works connected with the installation should be undertaken by the supplier. Test run should be conducted to demonstrate the suitability of the system after loading the chamber with lemongrass.
