### Terms and Conditions

1. The envelope containing tender should be super-scribed as“**Tender for 200 AH Solar Tubular Battery**” and should be addressed to the Dean of Faculty, College of Forestry, KAU P.O., Thrissur, Kerala -680656.
2. Tender should be submitted in the prescribed format which can be downloaded form the weblink: <https://forestry.kauin/tenders>. The cost of tender form is 0.2% of the amount quoted rounded to the nearest multiples

of 100, subject to a minimum of Rs. 400/- and maximum Rs. 1500/-+18% GST, which will be accepted by way of Demand Draft in favour of “Dean of Faculty, College of Forestry, Kerala Agricultural University, Vellanikkara, Thrissur” payable at state Bank of India Kerala Agricultural University and should be send separately along with the tender.

3. The “200 AH Solar Tubular Battery” should be delivered and installed at office of the College of Forestry and the rate quoted for each item should be inclusive of all charges, taxes if any and should be valid up to the supply of the items.
4. Each Tender should be accompanied by an Earnest Money Deposit (EMD) of 1% of the cost of the quoted items (subject to minimum of Rs.1500/- in favour of the Dean of Faculty, College of Forestry, Vellanikkara payable at State Bank of India, Kerala Agricultural University Campus, Vellanikkara. The EMD of the unsuccessful tenderers will be returned and that of the successful tenderers will be adjusted towards the security deposit (5% of the total value of the invoice) that will have to be deposited at the time of supply.
5. Tenders will be opened on .....19-01-2026 at 3.30 P.m... in the presence of tenders who may be present at that time.
6. If the date of opening of the Tender happens to be holiday due to unexpected circumstances like bandh, hartal etc., quotations will be opened on the next working day at the same place.
7. The undersigned has the right to accept or reject any or all of the offers without assigning any reasons. The decision of the undersigned in finalizing the tenders will be final and binding.
8. Tenders insisting on payment in advance either full or part are liable for rejection.
9. On acceptance, the supply order will be placed. The invoice should be addressed to the Dean of Faculty, College of Forestry, K.A.U. P.O.- 680 656. The payment will be effected only after proper delivery and installation of the items and on certification of satisfactory performance at the College of Forestry, Vellanikkara.
10. The items should be supplied with in a week on receipt of the supply order.
11. The Tenderer is liable to replace the defective articles/rectify the defective items if any, immediately on receipt of intimation.
12. The details of warranty, nearest service centres and other conditions should be indicated in the Tender.
13. All the rules and regulations applicable to Government Tenders will be

applicable to this case also.
