- 3. The tender should be accompanied by an agreement in Kerala Stamp Paper worth Rs.200/-(Rupees Two hundred only) and format can be downloaded from the above website. Withdrawal of tenders after its acceptances or failure to supply the equipments or not according to the specification will entail cancellation of the tender.
- 4. The sealed cover containing the tender documents should be super scribed as "Tender for Research Fermentor.
- 5. The successful tenderer should execute an agreement in Kerala Stamp paper worth Rs.200/- (Rupees Two hundred only) and furnish a security deposit of 5% of cost of the equipment quoted in the form of term deposit/bank guarantee/demand draft drawn in favour of The Professor & Head , Rice Research Station, Vyttila, payable at SBT, Vyttila The format of the agreement can be downloaded from the above website.
- 6. The cost of the item, tax and other charge should be separately stated for each item. The items should be supplied at our premises.
- 7. The exact specifications, details of make, model, name of the manufacturer, name of the Country etc of the item must be clearly specified. The technical literature and brochures of the item have also to be furnished along with the tender.

- 8. Warranty details, firmness of the quoted price should be clearly stated.
