Terms and conditions of supply of stationery articles.

- 1. Tenders should be superscribed as "Tender for the supply of stationery articles" and addressed to the Registrar, Kerala Agricultural University, KAU(P.O), Vellanikkara, Thrissur 680 656
- 2. Tenderers are allowed to quote for all items or for a part thereof
- 3. The date upto which the rate contract prevails is upto 31.03.2020
- 4. As per order No. G.O(P) No. 448/05/Fin dated 13.10.2005 all bidders are liable to remit EMD @ 1% of the total cost of articles tendered for and Security Deposit @ 5% of the total value of the contract by DD drawn in favour of the the Comptroller, Kerala Agricultural University payable at SBI, KAU Campus Branch, Vellanikkara. The EMD of the unsuccessful tenderers will be returned as early as possible, but that of the successful tenderer will be adjusted towards the Security Deposit (5% of the total value of the contract) that will have to be deposited for satisfactory fulfillment of the contract.
- 5. Delivery of the articles should be made at the Central Store, KAU Headquarters, Vellanikkara free of cost within 15 days from the receipt of supply orders
- 6. The tenders received without fulfilling the above conditions will be summarily rejected.
- 7. All rules relating to the Government tenders are applicable to this case also.
- 8. Right to accept the tender in total or in part or to reject it without assigning any reasons is reserved with the undersigned.
- 9. The last date of the receipt of the filled in tender form is at 2.30 pm on .../07/2019. The tenders will be opened at 3.30 pm on the same day in the presence of the tenderers or their authorized representatives who may be present at that time.
- 10. Samples of items must be produced along with the tender.
- 11. The rates quoted should be inclusive of all taxes, transportation and all such expenses to deliver the materials at KAU Central Store, Vellanikkara.
