Terms & Conditions

1. Tender should be submitted in the prescribed form which can be downloaded from the web link www.kau.in/tenders. The cost of tender form will be accepted by way of Demand Draft drawn in favour of Professor & Head, PPNMU, Vellanikkara payable at State Bank of India, KAU Branch, Vellanikkara and should be enclosed along with the tender. The tender cost (0.2%) and GST amount 18%) should be specified while submitting the tender.

Cost of Tender form	
Suppliers costing between Rs. 10,00,000/-	0.2% of the quoted amount rounded to the nearest multiple of ₹ 100/- subject to a minimum of ₹ 400/- and maximum of ₹1500/- + GST 18%
Suppliers costing more than Rs.10,00,000/-	0.15% of the quoted amount rounded to the nearest multiple of ₹ 100/- subject to a maximum of ₹ 25,000/- + GST 18%

2. The tender should be accompanied by an agreement in Kerala stamp paper worth ₹200/- (Rupees Two Hundred only), the format of which can be downloaded from the above website. Withdrawal of tenders after its acceptance or failure to supply the items or not according to the specification will entail cancellation of tender.
3. EMD @ 1% of the amount offered (subject to a minimum of ₹ 1,500/- should be remitted by the way of DD along with the DD for tender cost and GST amount mentioned above ie, Two

- separated Demand Drafts drawn in favour of Professor & Head, PPNMU, Vellanikkara payable at State Bank of India, KAU Branch, Vellanikkara. No other Demand Draft will be entertained.
4. The sealed cover containing the tender should be superscribed as "Tender of Chemicals for Ayar and Sampoorana production as per Tender Notice No. No.PPNMU-A2/2725/2025 dtd.27.12.2025
 5. The cost of item, tax and other charges should be separately stated, price quoted should be valid up to one year.
 6. Tenders will be accepted up to 11 am of 06.01.2026 Tenders received after the stipulated time will not be accepted.
 7. Tenders will be accepted at 11.30 am on 06.01.2026 at the presence of those bidders who are present at that time.
 8. The bidder of the accepted Tender should enter into an agreement with the Assistant Professor & Head, PPNMU, KAU, Vellanikkara on Kerala stamp paper worth ₹ 200/- The format of the agreement is available in the web link www.kau.in/tenders. He/she should also submit a security deposit equal to 5% of the cost of chemicals in the form of Term Deposit/Bank Guarantee/Demand Draft drawn in favour of Assistant Professor & Head, PPNMU, Vellanikkara payable at State Bank of India, KAU Branch, Vellanikkara payable at State Bank of India, KAU Branch, Vellanikkara.
 9. Analysis report of chemicals obtained from accredited laboratory should be provided for each lot supplied. The items supplied will be analysed for qualities at this end also before settling the invoice.
 10. The chemicals should be supplied in lots as required.
 11. Payment of cost of the chemicals will be made by invoice cum cheque basis. Supplier must have GST registration. All GST rules and Income Tax rules are applicable.
 12. Any failure on the part of supplier in the fulfilment of contractual obligations will result in the forfeiture of EMD/Security Deposit.
 13. All other technical and commercial terms and conditions as per the code rules in force in Kerala State will be applicable in this case also.
 14. If any bandh/strike/any unexpected holidays occurs on the date of opening of tender, tender will be opened at the same on the next working day.
 15. Late and incomplete tenders will not be considered at any circumstances.

Special Conditions

- i. Tenders insisting payment in advance either full or in part for in part for releasing the documents through bank are liable to be rejected.
