The rate quoted is valid for one year from the date of acceptance of the quotation.

The Head of office has the right to accept/reject any or all the quotations without assigning any reason.

The successful quotation should be valid for one year from the date of acceptance and the quotationer is liable to supply the materials at the accepted rates as and when required during the current year.
