Sl No	Works
1	Replacement /repair of damaged posts, trusses, purlins and applying a priming coat of steel primer to all metallic parts.
2	Replacing the existing UV film with 200 micron new UV film for the entire roof and all the sides
3	Replacing the existing Zig – zag spring and Aluminium channel lock for the cladding
4	Providing PVC gutters for collecting rain water for the two length sides of the structure
5	Demolishing the existing plastering of the half wall of 1 m height & replastering with cement mortar of 1: 6
6	Laying ½ “ rubble for 2” for the entire floor area
