Each quotation should be accompanied by Earnest Money Deposit (EMD) of 1% of the cost of the quoted items (subject to minimum of Rs.1500/-) by way of crossed Demand Draft drawn in favour of the Dean, College of Forestry, Vellanikkara payable at State Bank of India, KAU Campus (Branch Code 70670). Late and incomplete quotations and without EMD will not be accepted. Firms who are exempted from the payment of EMD should furnish copy of the currently valid certificates from Stores Purchase Department, Govt. of Kerala.

3. The successful tenderer should execute an agreement in Kerala Stamp Paper worth Rs. 100/-(Rupees one hundred only) at the time of supply of items and furnish a performance security deposit of 5% of the cost of the equipment quoted in the form of term deposit/bank guarantee /DD drawn in favour of Dean, College of Forestry, Vellanikkara payable at the SBI, KAU campus (Branch Code 70670).
