- 2.Retort internal shell fabricated with not less than 4mm thickness fabricated with SS 304L insulated with 100 mm thick ceramic wool cladding externally with 20 G of SS 304
- 3.Retort have suitable internal and external piping for steam, water and compressed
- 4.Retort have adequate numbers of properly designed steam nozzles, water sprinklers solenoid valve, gate valves, by pass valves, pre set spring loaded pressure safely valves, temperature, pressure guage and other necessary accessories
- 5.Retort units have suitable SS trolley and baskets
- 6.Retort system controlled by PLC which includes transformer, isolator, MCB, relays, display auto/manual selector, cycle on / end indicators
- 7.Retort have display indicators for steam, air, water valves on/off emergency hooter to indicate excess pressure
- 8.Retorts have rigid bottom iron frame work for Erection/ commissioning of the retort with suitable bolts and nuts
