GENERAL CONDITIONS

If any tenderer withdraws from his tender before the expiry of the period fixed for keeping the rates firm for acceptance, the earnest money, if any deposited by him will be forfeited to Kerala Agricultural University or such action taken against him as the University think fit.

The tenders shall clearly specify whether the articles offered bear Indian Standards Institution Certification Mark or not. In such cases, they shall produce copies of certification marks along with their tender in support of it.

The tenders shall clearly specify whether the goods are offered from indigenous sources, from imported stocks in India or from foreign sources to be imported under a license. The University reserve the right to reject offers for import of goods if the Import Trade Control Policy in force at the time of award of the contract prohibits or restricts such imports.

In case of imported goods, when the price accepted in the ex-site price quoted by the tenders, the benefit of any reduction in the c.i.f. price should accrue to the University. **University will not pay any customs clearance, freight, insurance charges, etc. The quoted rate should be inclusive of all these. For imported goods, the payment will be in INR and not in foreign currency.**

Tenders should be prepared to accept orders subject to the penalty clause for forfeiture of security in the event of default in supplies or failure to supply within the stipulated period.

Kerala Agricultural University reserves the right to accept whole or any part of any tender or portion of the quantity offered or reject it in full without assigning any reason.

Any legal disputes arising out of any breach of contract pertaining to this tender shall be settled in the court of competent jurisdiction located within the state of Kerala.

In addition to these, all other General Conditions annexed in the Store Purchase Manual of Government of Kerala are also applicable to this tender

NOW THESE PRESENTS WITNESS and it is hereby mutually agreed as follows:

1. In case the tender submitted by the Bounden is accepted by the University and the contract for the supply of any item of $______$ as per the above notification is awarded to the Bounden, the Bounden shall within fifteen days of acceptance of his tender, execute an agreement with the University incorporating all the terms and conditions under which the University accepts his tender.

2. In case the Bounden fails to execute the agreement as aforesaid incorporating the terms and conditions governing the contract, the University shall have power and authority to recover from the Bounden any loss or damage caused to the University by such breach as may be determined by the University, by appropriating the earnest money deposited by the Bounden and if the earnest money is found to be inadequate, the deficit amount may be recovered from the Bounden and his properties movable and immovable in the manner hereinafter contained.

3. All sums found due to the University under or by virtue of this agreement shall be recoverable from the Bounden and his properties movable and immovable under the provisions of the Revenue Recovery Act for the time being in force as though such sums are arrears of land revenue and in such other manner as the University may deem fit.

AMC and CMC: The rates of AMC and CMC for the next 3 years after the warranty period (standard warranty + CMC three year) should be furnished in separate sealed cover addressed to the Professor and Head before the closing date of the tender. This will not be considered as part of Financial Bid.

B.SPECIFIC TERMS AND CONDITIONS

Depart of Vegetable Science, College of Agriculture, KAU, Vellanikkara will only provide the installation room, and required electrical outlets. Vendors should supply all other installation accessories and services required for successful installation and smooth operation of the equipment

The supplier shall guarantee to repair/replace without any extra cost, the installation accessories supplied or part thereof, if found defective due to bad designing, workmanship or substandard material, within 12 months from the date of commissioning. The entire expenditure towards replacement/repair in this regard shall be borne by the supplier

All breakdown of the instrument should be addressed within 48 hours by an onsite visit.

IQ, OQ and PQ Certificate should be provided after installation.

ISO and CE certificate from manufacturer & factory performance test certificate should be provided.

After tender acceptance, the successful tenderer should supply, install and commission the items within 90 days of supply order.

On receipt of purchase order, the supplier shall execute another agreement within 15 days and furnish a Performance Security of 5% of the cost valid up to 60 days after the date of completion of performance obligations including warranty obligations.

Furnishing of wrong/ambiguous information in the compliance statement may lead to rejection of bid.

Prices shall be quoted only in INR

• The prices shall be quoted in Indian Rupees for delivery at F.O.R., Department of Vegetable Science, Vellanikkara on <u>Door Delivery</u> basis.

• Miscellaneous charges for delivery of imported items and installation and commissioning at Department of Vegetable Science, Vellanikkara should be included in the quote. We are exempted (regd. with DSIR) from payment of customs and excise duty for our procurements and hence prices quoted should be exclusive of these. Necessary documents for availing customs duty exemption will be provided to the tenderer to facilitate import on behalf of KAU.

Suppliers shall be entirely responsible for **packing**, **forwarding**, **freight**, **insurance charges**, all duties, taxes, license fees, octroi, road permits, insurance, clearing charges, etc., incurred until delivery of the Goods to the Purchaser including imported components. Nothing extra will be paid in addition to quoted rates. Miscellaneous charges in INR for labour, services, transport, installation, training for entire components must be included in BOQ

If an Indian agent is involved, the following document must be enclosed.

a)Foreign Principal's proforma invoice indicating the commission payable to the Indian agent and nature of aftersales service to be rendered by the Indian agent.

b) Copy of the agency agreement with the foreign Principal and the precise relationship between them and their mutual interest in the business.

c)The enlistment of the Indian agent with the Director General of Supplies and Disposals under the compulsory registration scheme of Ministry of Finance.

Payment of Agency Commission: Payment shall be made in Indian Rupees within Thirty (30) days of delivery of goods and that all other contracted services have been performed.

For supplies in INR, 100% payments will be released after successful installation and commissioning of the entire system

Country of origin, Country of import and port of shipment should be specifically written in the Tender document.

While trans-shipment will be allowed, part shipment will not be allowed.

Any attempt to manipulate the specification sheet/ instrument performance evaluation performed in the application laboratory / quote substandard / refurbished equipment /accessory /internal parts will be viewed seriously as per guidelines issued by CVC in their regulations. Only specification sheets available in the website of the principal company is taken as approved specification of that quoted model. The electronic version of the same may be reproduced on demand. Unauthorized /doubtful specification sheets containing tenders are subject to rejection.
