Sealed competitive limited tenders are invited for fixing 120 nos of GI posts by digging pits and PCC concreting including centering and shuttering work upto plinth levels in the southern boundary of the station.

Details of work

1. Nearly 120 pits of 0.5 x0.5x0.6 m³ are to be taken
2. A layer of 2 ” rock gravels is to be put in pits before concreting
3. Fixing of GI posts and laying in position by PCC 1:2:3 concrete mixture with specified grade cement including cost of centering and shuttering work up to plinth levels.
4. The rates should be inclusive of cost of materials, transportation and unloading charges.
