- Authorization Certificate, if the bidder is a dealer -addressed in favour of Associate Director of Research , RARS Pattambi
- Agreement in Kerala stamp paper worth Rs. 200/- (Rupees Two Hundred only), the format of which can be downloaded from the above website. Withdrawal of tenders

after its acceptance or failure to supply the items or supplying items not according to the specification will entail cancellation of tender and forfeiture of EMD.

The cost of tender form is Rs.400/- + 18% GST (ie. - 3. The tender should be accompanied by an agreement in Kerala stamp paper worth Rs. 200/- (Rupees Two Hundred only), the format of which can be downloaded from the above website.
- 4. EMD amount of Rs. 2000/- should be remitted along with the tender cost of Rs.472/- by two separate Demand Drafts drawn in favour of Associate Director of Research, Regional Agricultural Research Station, Pattambi payable at State Bank of India, Pattambi. No other Demand Draft will be entertained.
- 5. The sealed cover containing the tender should be super scribed as "**Tender for Supply of chemicals, glassware's, plasticwares, other labwares and minor equipments**", as per tender notice No. **RARSCZ/3571/2025-D3 16-01-2026**
- 6. Tenders will be accepted up to 02:00 PM on 29.01.2026. Tenders received after the stipulated time will not be accepted.
- 7. Tenders will be opened at 02:30 PM on the same day at the presence of bidders/ their representatives who are present at that time.
- 8. The bidder of the accepted tender should enter into an agreement with the Associate Director of Research, Regional Agricultural Research Station, Pattambi on Kerala stamp paper worth Rs. 200/. The format of the agreement is available in the web link www.rarsptb.kau.in/tenders. He should also submit a security deposit equal to 5% of the cost of above mentioned items in the form of Term Deposit/Bank Guarantee/Demand Draft drawn in favour of Associate Director of Research, Pattambi, payable at State Bank of India, Pattambi.
- 9. The quoted discount rates on catalogue price shall remain in force throughout the tenure of the rate contract and no revision is permissible for any reason.
- 10. If any reduction is made in the price list, the new price will be applicable for all future purchases.
- 11. The items supplied should be of specified quality as per the catalogue of the firm.
- 12. The items should be supplied in lots as required.
- 13. Payment of cost of the items will be made by invoice cum NEFT basis.

14. Any failure on the part of supplier in the fulfilment of contractual obligations will result in the forfeiture of EMD/Security Deposit.
15. Tenders insisting payment in advance either full or in part for releasing the documents through bank are liable to be rejected.
16. The undersigned reserves the authority to accept or reject any or all of the offers for items without assigning any reason whatsoever.
