- 1. Tender should be submitted in the prescribed forms which can be downloaded from the website <u>www.kau.edu/tenders</u>. The cost of tender form will not be refunded under any circumstances.
- 2. The sealed cover containing the tender should be superscribed "Tender for construction of First Floor of Academic Building, College of Climate Change and Environmental Science" should be addressed to the DEAN, CCCES, Vellanikkara, KAU-680 656.
- 3. Each tender should be accompanied by tender fee and an Earnest Money Deposit subject to minimum (EMD) of 2.5% of the total rupee equivalent cost of the quoted items (subject to maximum of Rs.50,000/-) by way of two crossed Demand Drafts separately for tender fee and EMD drawn in favour of DEAN, CCCES, Vellanikkara, KAU-680656 payable at the State Bank of India, KAU Campus, Vellanikkara. Late and incomplete tenders and tenders without EMD, tender fee and agreement will not be accepted.
- 4. The tender should be accompanied by an agreement in Kerala Stamp Paper worth Rs. 200/- (Rupees Two hundred only) and format can be downloaded from the above website. Withdrawal of tenders after its acceptance or failure to supply the equipment or not according to the specification will entail cancellation of the tender.
- 5. The successful tender should execute an agreement in Kerala Stamp Paper worth 1% of agreed PAC rounded to nearest multiple of Rs. 50/- or with a minimum of Rs. 200/- (Rupees Two hundred only) and furnish a security deposit of 5% of the cost of construction quoted in the form of terms deposit/bank guarantee/demand draft drawn in favour of DEAN, CCCES, Vellanikkara, KAU-680656 at the State Bank of India, KAU Campus, Vellanikkara, when directed from this office. The format for the agreement can be downloaded from the above website. Firms who are exempted from payment of EMD should furnish copy of the currently valid certificate from the store Purchase Department, Govt. of Kerala.
- 6. The cost of the construction, tax and other charges should be separately stated.
- 7. Prices quoted should be valid upto 120 days beyond.
- 8. The decision of the undersigned in finalizing the tenders shall be final and binding
- 9. If any Bandh/Strike/any unexpected holidays occur on the date of opening of tender, the tender will be opened at the same time on the next working day.
- 10. On acceptance the work order will be placed and the invoice should be address to DEAN, CCCES, Vellanikkara, KAU-680656. The payment will be effected only after satisfactory completion of the work.
- 11. List of users giving the exact address of the contact persons and the model number of the units available at these locations, have to be provided. Evidence of exclusive/authorized distributorship from foreign principals should be provided along with the offers for overseas products.
- 12. The DEAN, CCCES, Vellanikkara, KAU has the right to accept to reject or reject any or all of the offers without assigning any reason.

13. All the rules and regulation application to Government Tenders will be applicable to this tender also.

## ELIGIBILITY CRITERIA

The bidders should fulfill the following eligibility criteria for participating in the Tender. *The bidders should enclose self-attested documentary evidence in support of Fulfilling the eligibility criteria.* 

- 1. The bidder should be an agency with accreditation of govt. of Kerala and have been listed as per the G.O(P)No.104/2022/Fin dated 02.09.2022
- 2. The bidder should have a valid Constitution of the firm i.e. Certificate of MSME
- 3. Registration of the firm /Company Registration Certificate/ Memorandum & Articles of Association / Partnership deed (if individual, copy of Identity proof, Electoral card / Aadhar card duly attested).
- 4. The bidder should have valid GST registration, PAN Card etc.
- 5. The bidder should have experience to execute the same nature of work with in last two years.
- 6. GST returns latest or Latest Income Tax /Copy of Tax return filed/Chellan copy of Tax remitted. (Copy to be attached, if applicable)
- 7. Banker's name & address and details of Bank Account Number of the bidder.
