Dozer Machine

Semi soild dozer for dozing with a particle upto 8 X 8 mm

Dozing range – 50 to 1000 gm

Volume of hopper – 25 ltr

MOC – SS 304 with 3 hp compressor (compressed air FAD at 6 kg/cm2 100 L/min) with push fill mechanism PPF with pneumatic piston and push rod

For filling pickles and jam

- 5. Successful tenderers will have to execute an agreement and remit security deposit @ 5% of the value of the articles ordered, less the amount of EMD, drawn as DD or fixed deposit receipt.
