5. Successful tenderers will have to execute an agreement and remit security deposit @ 5% of the value of the articles ordered, less the amount of EMD, drawn as DD or fixed deposit receipt.

6. The sealed cover containing the tender documents should be superscribed "Tender for supply of tractor" and sent to The Professor and Head, KVK Malappuram, KCAET Campus, Tavanur PO, Malappuram, PIN 679573.

7. The supply has to be made in a period of one week from date of placement of supply order.

8. The rate quoted should be inclusive of all charges including GST if any and also connected expenses if any. The transportation cost also should be included in the rate.

9. The rate will be valid for the financial year 2021-22. The payment will be through invoice/credit bill system and by cheque only.
