Late and incomplete tenders and tender without EMD, tender fee and agreement will not be accepted. Firms who are exempted from the payment of EMD should furnish copy of the currently valid certificates from Stores Purchase Department, Govt.of Kerala.
- 3. The envelope containing the tender should be super scribed as —"Tender for the supply of Vertical autoclave/ Spilt AC- 1.5 ton" and should be addressed to the 'The Programme Co-ordinator, Krishi Vigyan Kendra, Kumarakom, Kottayam, 686563.
- 4. The successful tenderer should execute an agreement in Kerala stamp paper worth Rs.200/-and furnish a security Deposit of 5% of the cost of the items quoted in The Professor & Head, Krishi Vigyan Kendra, Kottayam payable at the State Bank of India, Kumarakom Branch (IFSC code: SBIN0070116). The format of the agreement can be downloaded from the above website. Withdrawal of tender after its acceptance or failure to supply the items as per specifications or not according to the specifications will entail cancellation of the tender.

- 5. The items should be delivered at the site in the rate quoted for each item should be inclusive of all charges, taxes if any, and should be valid for one year w.e.f. the date of issue of supply order.
- 6. Period of firmness of the quoted rates/price should be clearly stated in the offer.
- 7. Tenders will be opened in the presence of the tenderers who may be present at that time.
- 8. If the date of opening the tender happens to be a holiday due to unexpected circumstances like bandh, hartal etc., tenders will be opened on the next working day at the same place.

Split type air-conditioning unit shall comprise of hermetically sealed compressor, air cooled fin-tube condenser, low noise, low speed, statically & dynamically balanced forward curve centrifugal fan, dry type steel wire reinforced HDPE air filter, volume control damper, fin-tube evaporator coil made of heavy duty copper tube and integrally finned corrugated copper fin, drive motor, heavy gauge sheet metal cabinet, vibration isolator pad, condensate pan, control and instrumentation system, etc. The split type air-conditioners shall conform to IS 1391(Part 2): 1992 and suitable for refrigerant R-32.

Scope of work:

- 1. Supply, installation, testing and commissioning of the air conditioning (AC) equipment.
- 2. One year maintenance as per OEM supplier warranty.
- 3. Supply of all consumables and commissioning spares.
- All associated electrical works such as cabling for input power including starter, cable tray, along with interconnection between outdoor and indoor units.
- 5. Supply and erection of all hangers, stands for both indoor and outdoor units
- 6. Outdoor unit of the machine to be mounted on exposed wall at a suitable height for ease in maintenance.
- Anti-vibration pads for outdoor units to be used.
- 8. All associated civil works for erection of the AC machine.
- 9. Slope of drain pipe to be maintained for proper draining
- 10. Piping for Outdoor unit shall not be more than a distance of 3 m from indoor unit
- 11. Perforation on the wall to be made at a downward angle to ensure no water seepage. It should be plugged using suitable sealant other than cement.
- 12. U-bend to be provided on gas piping to ensure no water seepage over piping.
- 13. Refrigerant piping shall be insulated for the entire length.
