Withdrawal of tenders after its acceptance or failure to execute the work in time or comply with the specification will entail cancellation of the tender.

Earnest Money Deposit (EMD) @ 1 % of the amount offered (subject to a minimum of Rs.1,500/-) should be remitted along with the tender cost by two separate Demand Drafts drawn in favour of the Professor and Head, ARS Anakkayam and payable at SBI, Manjeri Town. No other Demand Draft will be accepted
- 5. The sealed cover containing the tender should be super scribed as "Tender for Repair and maintenance work of Polyhouse" as per tender notice No. A1-487/2023(i) dated:02.03.2023 and sent to the Professor & Head, ARS Anakkayam, Malappuram Dt, 676509
- 6. The tenders will be accepted up to 2.00 pm on 13.03.2023. Tenders received late or incomplete in any respect will be summarily rejected without notice and the decision of the undersigned on such matters will be final.
- 7. The tenders will be opened at 2.30 pm on the same day in the presence of those bidders who are present at that time. The lowest rate will be accepted if reasonable.

- 8. Prospective bidders may inspect the site before submitting the tenders with prior permission of the Professor and Head, ARS Anakkayam
- 9. The bidder of the accepted tender should enter into an agreement with the Professor and Head, ARS Anakkayam on Kerala Stamp paper worth Rs.200/-. The format of agreement is available in the web link <a href="http://www.kau.in/tenders">http://www.kau.in/tenders</a>. He should also submit a security deposit equal to 5 % of the bid in the form of Demand Draft drawn in favour of the Professor and Head, ARS Anakkayam and payable at SBI, Manjeri Town.
- 10. The work has to be made in a period of 7 days from date of work order.
- 11. The lowest tender will be identified based on the lowest cumulative total of all the items taken together for the above said work.
- 12. The rate quoted should be inclusive of cost of items (with tax), Transportation and Labour charges and which should be mentioned separately
- 13. The rate will be valid for the financial year 2022-23. The payment will be through invoice/credit bill system and by cheque/transfer.
- 14. Tenders insisting payment in advance either full or in part for releasing the documents through bank are liable to be rejected.
- 15. Income Tax in the eligible rate will be recovered from the final payment of the labour charge.
- 16. The decision of the Professor and Head, ARS Anakkayam will be final and abiding.
